

KEY COMPONENTS OF SOLAR PROJECTS

- Ground mounted PV (photovoltaic) panels lined up across open fields. These are tilted to capture maximum sunlight and are 4-10 feet high.
- Semiconductor panels convert energy of the photons in sunlight into electrons that form electric current.
- Invertors convert electricity from DC to AC.
- Transformers step-up voltage to deliver to utility grids.
- Energy storage eg. Batteries
- Generally the Solar Projects is surrounded by a fence to secure access roads, and panels and minimizes visual impact.

Can I sell my land at any time?

You have total flexibility to sell your land at any time during our arrangement. A Solar lease can actually enhance your land's value.

During the development phase, can I continue with my current business operations?

You can continue with any ongoing operations during the development phase.

Is the income guaranteed and stable?

Indeed, the income from land lease is reliable and stable. AMPYR Energy will agree a lease rate with yourself which will be paid once the Solar Power Plant is commissioned. Also, rent will be paid during the Development and Construction phases. Solar Project rental income is considered favorably by banks/ lenders for landowners to avail of loans against it as the security.

Will a solar installation disturb my neighbors?

Once complete, Solar and Battery Projects have minimal moving parts and noise. For the most part, the system simply sits there, generates & stores electricity.

How will this affect my land?

The Solar Project will preserve both, the physical aspects of land and also its valuation. Solar Projects do not move soil from your property and do not create and waste or effluent discharge. The property valuation would reflect the steady long term rental income, and make it an attractive prospect for any potential buyer in case you consider selling anytime.

What will the installation look like?

A detailed blueprint of the panel design and layout map can be presented once the design is finalized.

Will my land be restored at the end of the lease?

Yes, at the end of the lease period, the project owner will remove all the project infrastructure and hand your land back to you in it's original state.
